- 1. Firm/Bidders must supply an original Equipment Manufacturer of Safes. Trade licence and ISO certificate of OEM should be provided.**
- 2. Firm/Bidders must not have been blacklisted by any Govt. / State Bank of India/PSU/RRB anytime in the past for similar physical security product in last 10 years.** A declaration by OEM should be given in this regard.
- 3. OEM should have their own office in the state of West Bengal. GST Certificate of OEM for West Bengal is mandatory as eligibility criteria.**
- 4. Firm/Bidders must have minimum 5 years' experience in supply and installation of the products in tender .**
- 5. OEM must have their own office/branch Office in West Bengal** and PAN India and having minimum 50 qualified service engineer for PAN India and 5 in local area on their payroll (proof of identity required- Id Card/Employee no./telephone no./PF no etc). such office must have registration with "shop & Establishment" with the local authority and must be manned during office hours. A declaration by OEM should be given in this regard.
- 6. Firm/Bidders must submit a latest BIS License** for manufacture and supply products and the license must also be valid as on date of application.
- 7. The Company's Trade License and / or memorandum in the Company registration under Companies Act' should reflect the Items (Safe, Safe with Safe Deposit Lockers and Fire-Resistant Filing Cabinets) as business as one of the area of operations of the Bidder. Documentary proof in this regard should be submitted.**
- 8. The bidder should have registered and well-established own offices and dealer offices in PAN India. List of all offices should be attached. Documentary proof in this regard should be submitted.**
