The Bid validity period will be two years. That means Bank will issue Purchase Request on - as and when required – basis throughout the Bid validity period.

Terms and Conditions:

- 1. The quoted price should be inclusive of all taxes, duties, carriage and installation charges etc.
- 2. The delivery and installation should be completed within 2(Two) days at the Branches from the date of placement of Purchase Request.
- 3. The Bank reserves the right to check the materials by a third party at its choice.
- 4. During the warranty period the successful vendor shall be liable for any defects in the work due to bad quality of materials supplied or workmanship and shall rectify all defects at its own cost. If the successful vendor fails to attend or rectify the defects within 24 hours from the time of its reporting, the Bank authority will have the option to contract with any third party to solve the problem. The cost incurred to repair the defect will have to be borne by the successful vendor. During the warranty period, the vendor shall maintain the equipments and repair / replace the defective spare parts at site. No extra charges will be paid to the vendor for this purpose.
- 5. In case of any dispute, the settlement will be made in the Court of Midnapore.
