- 7) No deviation from the specification shall be allowed without prior consent of authority.
- 8) The contractor shall make arrangements for storage of material, tools and equipment etc at the site and Bank shall not bear any expenses and risks also on this account.
- 9) The vendor shall observe all necessary precautions at his cost to safeguard the workers during execution of work.
- 10) Payment will be made on successful completion of work as per work order through NEFT/ RTGS.
- 11) The undersigned is the accepting authority who reserves the right to reject any or all quotation without assigning any reason or he will not be bound to accept either the quotation rate at any of the bidders.

- 12) Supply and installation of the system with all accessories and any item not concerned in the specification but essential for proper installation, operation and maintenance of air conditioning system during the period of warranty shall be included & executed by the vendor. The supply will not be deemed complete until the commissioning trial of the whole system is carried out by the vendor.
- 13) The vendor shall provide warranty/guarantee for the entire system for a period of 12 months from the date of commissioning. In case of compressor the warranty should be of 5 years. The vendor shall be responsible for routine & break down maintenance of the equipment during warranty period.
- 14) 50% payment shall be made against acceptance delivery and 50% payment shall be made against installation and commissioning of the machines.
- 15) TDS will be deducted as per norms.
