- 4)** No advance or running payment shall be made. Payment shall be released after the satisfactory work as mentioned above and providing & fixing of allied works.
- 5)** No deviation from the specification shall be allowed without prior consent of authority.
- 6)** All rubbish and superfluous materials shall be removed from site at the cost of contractor after the completion of work and prior to submission of final bill. Rubbish may be disposed outside of premises.
- 7)** The contractor shall make arrangements for storage of material, tools and equipment etc. at the site and Bank shall not bear any expenses and risks also on this account.
- 8)** The contractor shall observe all necessary precautions at his cost to safeguard the workers during execution of work.
- 9)** 90% payment against inspection acceptance delivery and completion of works and balance 10% will be paid after 6 months of warranty period. And also that the Payment will be made on successfully completion of work as per work order through account payee cheque or by transfer through NEFT/ RTGS .
