- 1) Amount of commission shall be fixed on the volume of Gold Loan Amount of each Loan cases as per following manner :

Quantum of Gold Loan per Case in Rs.	Commission (in Rs.)
Up to 10000.00	Rs.125.00
10001.00 - 50000.00	Rs.175.00
50000.00- 100001.00	Rs.250.00
100001.00 – 200000.00	Rs.300.00
Above 200000.00 (Only for OD Gold Loan)	Rs.500.00

- 2) Gold appraisers will be allowed an allowance for the day they appear the Branches for Demand (Gold) Loan in the following manner :
- a) An amount of Rs.100.00 (Rupees One Hundred Only) in case of appraisers residence is within 10 (ten) KM from the Branch.
 - b) An amount of Rs.150.00 (Rupees One Hundred Fifty Only) in case of appraisers residence is beyond 10 (ten) KM from the Branch.

N.B : The remuneration may be varied as per direction or order issued by the competent authority from Time to time.
