If the successful vendor fails to attend or rectify the defects within 24 hours from the time of its reporting, the Bank authority will have the option to contract with any third party to solve the problem. The cost incurred to repair the defect will have to be borne by the successful vendor. During the warranty period, the vendor shall maintain the equipments and repair / replace the defective spare parts at site. No extra charges will be paid to the vendor for this purpose.
5. 95% payment will be made after completion of installation, testing and successful commissioning of machines as certified by the HO Personnel. Remaining 5% payment will be made after six months from the date of successful installation of all the machines.
